Annual report of the Members of the Vestry

The Vestry presents the annual accounts for St Mary's for the year ended 30 September 2018.

This annual report and accounts presents a summary of our financial activities during the year and gives an overview of the general activities which have taken place in the life of our church in the past year.

Hereinafter "the church" shall refer to the combined finances of St Mary's church and St Mary's Trust.

Activities and Achievements

Charitable giving remains at the core of the church's activities. This year the following charities have received donations; Toilet Twinning £360, Freedom Unlimited Ent. £400, Free Cakes Edinburgh £200, The Grassmarket Project £400 were all granted following vestry approval. The vestry also approved a donation to Ratho Primary School which is not a charity, but with the intention of supporting the wider local community; the donation was for £700. St Mary's also paid £500 as payment for the third year of our four year commitment to sponsor an ordinand in Papua New Guinea.

Details of the amounts given are shown in the accounts and notes thereto. Further, our connection with Mary's Meals continues, principally through the demijohns for small change in the church and hall. It should be noted that the amount donated this year is lower than previous years.

If members of the congregation wish to propose a cause to be considered for charitable giving during the coming year, bring this to the attention of a vestry member. The majority of the charities supported this year came from suggestions by members of the congregation.

Energy bills, are a little higher than the previous year figures. At around £5,000 these contribute a very significant part of the expense of running the church and associated buildings.

The rates for the coming year have been negotiated with supplier. As a result no major rise in energy bills is expected.

In the past year some refurbishment work has continued in the Rectory to bring it up to the standard required for the Rector to live there. There has been the purchase of a dishwasher, including installation, and a tumble dryer . The cost of this has been met mainly from the St Mary's Trust Account. A replacement garage door was also purchased. This was paid for from the church account as the supplier did not accept cheques and currently we can only make online payments from the church account. The church ride on mower was serviced and brought back into working condition. The rector's husband Ben Bright has since used this to great advantage by clearing a large piece of land adjacent to the rectory with a view to using this for youth programmes in the future. Some of the smaller Maintenance items in the rectory have been paid from the General Account. The other main Maintenance items paid from this account have been Church and Grounds electrics and continued rodent control for the Rectory.

Under the Grounds and Maintenance heading St Mary's continues to be indebted to Graeme MacBride who has cut the grass for the last four years. Having Graeme carrying this out is a big saving as otherwise St Mary's would likely have to employ someone to do it at a considerable cost. So a big thank you to Graeme.

In the past year some stonemasonry work has been undertaken on the church. This has been paid from the church account. It has been identified that significant repointing work is required on the rectory. There are still funds available in the St Mary's Trust account for this work to be undertaken; the Fabric Committee are currently investigating the eligibility of grants for this work due to the building's listed status.

Income

St Mary's relies chiefly upon the generosity of its congregation for most of its day to day funding. Smaller amounts are generated by fundraising activities. One of these is the money donated on a Sunday morning for coffee/tea after the service. This brings in around £700 a year.

St Mary's still attracts a number of wedding couples, and the income generated from this remains important. This ministry is important to the church's finances. Continued thanks are due to Carole MacBride for her role as Wedding Coordinator. It was agreed in the last year to increase the charge for weddings so it is inline with other providers. The new fee of £650 also includes Alan Phillips' Organist fee of £98 as there had been confusion in the past by couples having to pay this separately. The increased income per wedding is £23 or £72 if the services of an organist are not required.

Additionally, the Douglas Trust makes a material contribution towards the Rector's stipend and National Insurance contributions. The contribution has been increased by 50% to £6,000 per annum in the last financial year.

Congregational giving has increased against last year following a request by Geoff Angell to the congregation to increase their donations where possible. In the last year the paying of a stipend and rector's pension payments have resumed. However the payment for September's stipend was not collected until October so will show reflect in the next financial year. Given we have been paying a stipend this year our end of year funds total has been better than anticipated with only a decrease of circa £3k on the previous year. This is partly due to the performance of the SEC Unit Trust. We have also had some increase of the hall rental. It is hoped to pursue this as a viable revenue stream going forward following the recent redecoration in the church hall.

The Gift Aid Return from HMRC figure has decreased on that received in 2016-2017. Congregational giving has increased from £25,275 to £27,879. Geoff Angell has written to HMRC regarding the payment received being lower than expected. HMRC have made no allowance for the GASDS, which should be an additional return from HMRC in the region of £400. We were expecting to continue to take advantage of the government Gift Aid Small Donations Scheme (GASDS) which was introduced in April 2013. This scheme allows us to claim Gift Aid on the Sunday Open Collection within certain rules.

Reserves

The reserves of the church are held mainly in bank accounts, one current account each for the church and for St Mary's Trust, and a deposit account held for the church at Triodos Bank. The St Mary's Trust account is reserved for upkeep to buildings and grounds.

Within general funds there are specific reserves. A small surplus remains in the Organ Restoration Fund following payments for repairs this year; the Rector's Discretionary Fund and a Legacy Fund.

The church's reserves remain sufficient that in the event of a significant loss of income, the church would be able to maintain its current level of activities for a reasonable period until replacement funding is obtained, as is required in our constitution.

Investments

St Mary's invested £20,000 in the Scottish Episcopal Church Unit Trust Fund in January 2014. Further investments of £7,500 and £5,000 were made in January 2016 and July 2017. Due to our policy of reinvesting any dividends to buy more Units we currently own 2,753 Units. The Book Value of these Units is £37,192.61. The Market Value of the Units on September 30th was £19.5323 per Unit making the current value of the investment £53,772.42. It should be noted that the market value of the units can go down as well as up. Therefore the value of the units will be regularly monitored. Should there be a requirement to sell units in the future any instruction to do so will be actioned at month end with the monies received going directly back into the General Account.

Structure, governance and management

The church is a registered charity in Scotland (SC014203). As a member congregation of the Scottish Episcopal Church, it is governed by Canon Law of the Scottish Episcopal Church. The management team of the church is known as the Vestry. For the purposes of charities law, the members of Vestry are the Charity Trustees of the church. Details of the Vestry members are given on the front page. The trustees of St Mary's Trust are the Bishop of Edinburgh, the Dean of Edinburgh, the Earl of Morton and the Rector of St Mary's Dalmahoy.

Full details of Vestry electoral processes, terms of service and other details are given in other reports to the Annual General Meeting, and in the constitution.

The Rector appoints one member of Vestry, the Rector's Warden, himself. The Treasurer is formally appointed by the trustees of St Mary's Trust, on the recommendation of the Vestry.

Vestry responsibilities

These are outlined in detail in the constitution of the church.

Relationship with Diocese and Province

St Mary's is supported by the Diocese of Edinburgh and the Province of Scotland through the pastoral oversight of the Bishop and by central support functions provided at Diocesan level. [Note: it is also supported financially by a quarterly grant from the Douglas Trust, as a contribution towards the Rector's Stipend.]

The church is represented at Diocesan level by the Rector and the Lay Representative.

As a member of the Scottish Episcopal Church, St Mary's has an obligation to contribute towards the costs of Diocese and Province through payment of the annual quota. This amount is based upon the relative level of income of the church in comparison with that of other churches in the Diocese and Province. Details of this amount are in the main accounts.

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 30TH SEPTEMBER 2018

1 ACCOUNTING POLICIES

These accounts are prepared on a **receipts and payments** basis, rather than an accruals basis, as is permissable for charities with gross income below £250,000.

The accounts have been prepared, as far as possible, in accordance with applicable accounting standards, the Charities and Trustee Investment (Scotland) Act 2005, and the Charities Accounts (Scotland) Regulations 2006.

Giving, donations and other income All the above items are accounted for when received. Gift Aid is accounted for at the time when received from HMRC. We currently operate on a six monthly cycle for Gift Aid claims.

2 FUNDS

General Fund This is the contents of the main church account aggregated with the deposit account (30 Days notice) held with Triodos Bank, when the balances of the organ restoration, legacy and rectors discretionary funds are netted out.

Organ Restoration Fund This is the balance of funds from the organ refurbishment project, and is held in a restricted fund to contribute towards future repairs and enhancements. Regular tuning and maintenance is paid for out of general funds. The organ required some significant repair work to be carried out this year. The invoice was paid from this fund.

Rectors Discretionary Fund There were no payments from this fund during the year. There was one incoming donation

Legacy Fund There were no transactions on this fund during the year.

All of the above funds are in the general church account, with a surplus held in the Triodos Bank deposit account. The only fund held in a segregated bank account is :

St Mary's Trust This fund is restricted to the upkeep of the properties for which we have responsibility. There were payments of £4,165 made from the Trust account this year. These were mainly for refurbishing the rectory.

As St Mary's did not have a Rector until Christine took over in December no Stipend, National Insurance or Pension payments were made in October and November. Also the September 2018 Stipend payment was not taken until after end of year and so will show in next years accounts. The Rector's Expenses include a one off payment of £1560 to reimburse the costs of the visas that Christine required to allow her to work in the UK.

4 GRANTS GIVEN

For special appeals, such as the Caribbean Appeal, it is the policy of Vestry to take donations directly into church funds, claiming Gift Aid thereupon where appropriate. The total is then rounded up and sent to the beneficiary. Gift Aid is then reclaimed for the church. Were church reserves to run so low as to make this a hazardous practice, this policy would come under review.

The Vestry approved donations to Freedom Unlimited Enterprises, Free Cakes Edinburgh, Ratho Primary School, Toilet Twinning and Grassmarket Project. The other items noted came from monies collected from the congregation for these specific purposes. The third year of the vestry approved sponsorship of an ordinand in Papua New Guinea at £500 per year over four years was also made. A final £500 payment will be made in the next financial year. Additionally there were two retiral collections in December for Mary's Meals resulting in a payment being sent for the sum of £1,037.75.

5 INVESTMENTS AND FIXED ASSETS

No value is ascribed to church property, which is held in trust. Should the charity cease to use it, the ownership would revert to the estates of the Earl of Morton, hence has no heritable value to the church.

Beyond the current and deposit accounts, the investments of the church has one other form of investment:

This the investment of £20,000 in the Scottish Episcopal Church Unit Trust Fund in January 2014. Further investments of £7,500 and £5,000 were made in January 2016 and July 2017 respectively. Dividends are paid half yearly and, as agreed, these are reinvested to purchase more Units. St Mary's currently owns 2,753 Units. The Book Value of these Units is £37,192.61. The Market Value of the Units on September 30th was £19.5323 per Unit making the current value of the investment £53,772.42. It should be noted that the market value of the units can go down as well as up. Therefore the value of the units will be regularly monitored. Should there be a requirement to sell units in the future any instruction to do so will be actioned at month end with the monies received going directly back into the General Account.

6 QUOTA

Quota is payable by St Mary's to the Diocese of Edinburgh to support the work of the Diocese and of the Scottish Episcopal Church as a whole. The amount of Quota paid shows as higher in this years accounts than in 2016/2017. This due to the fact that to fit in with diocesan processes Quota is now being paid by 12 monthly payments (Jan-Dec). In previous years it was paid in 10 instalments (Dec-- Sep). Therefore the 2016/2017 figure of £5607 only covered 10 months as noted in the accounts. The 2017/2018 figure of £8,645 covers a full year.

7 MAJOR PROJECTS

In the past year further work has been carried out in the Rectory to bring it up to the standard required for our new Rector to live there. This has included the purchase of carpeting and white goods. The cost of this has been met mainly from the St Mary's Trust Account.

Some of the smaller Maintenance items in the rectory have been paid from the General Account. The other main Maintenance items paid from this account have been Church electrics, Church stonework, and rodent control for the Rectory.

Gift Aid from offerings are now claimed twice yearly. In 2016/2017 £8,484 was claimed and in 2017/2018 £7,222 was claimed. As can be seen from these figures Congregational Giving has gone up this year with some new and some increased GA donations being made. The GA benefit of this will not be seen until 2018/2019. It is still a concerning area which St Mary's needs to be aware of and give thought as to how income can be increased in coming years either through congregational giving or other new income streams.

9 LEGACIES

There were no incoming legacies or payments from the legacy fund this year.

10 GRANTS RECEIVED

The Douglas Trust makes a grant of \pm 1,500 per quarter to the church as a contribution towards the Rector's stipend. This was increased from \pm 1,000 per quarter this financial year. St Mary's is very grateful for this grant.

Utilities bills were similar to last year mainly due to continuing to negotiate an acceptable charging model from British Gas. The Rectory was empty until December and the fuel costs up until then were paid by the church. Administrator salary is slightly lower as the September 2018 payment was not taken before financial year end.

I report on the accounts of St Mary's Church, Dalmahoy ("the church") for the year ended 30 September 2018.

Respective responsibilities of trustees and examiner
